



## Three Happy Tails, LLC Boarding and Day Care Agreement

**Vaccinations/Medical Records:** Three Happy Tails, LLC requires written proof that your pet's vaccines are up-to-date & were given by a licensed veterinarian. Three Happy Tails, LLC is allowed access to your pet's veterinary records should an event arise where it is necessary for the health of your pet or for legal reasons. Required vaccines: RABIES, DISTEMPER/PARVO, BORDATELLA, INFLUENZA (H3N2/H3N8) We recommend waiting 48 hours after any vaccine has been administered to have your pet in our facility. Irritation to the injection site, swelling, & even allergic reaction to vaccines may occur. If you would still like to have your pet boarded or in day care within that 48-hour period, initial below to acknowledge you are aware of stated risks. **INITIAL:** \_\_\_\_\_

**Parasite Control:** All animals must have a negative fecal screening for intestinal parasites within 6 months of their stay. Due to the high volume of dogs in our facility we highly recommend your pet be on monthly flea & tick prevention in order to maintain a parasite-free environment. Upon arrival, your dog will be inspected for fleas and if any are found Three Happy Tails will provide treatment at an additional charge.

**Medications:** All pet parents are responsible for providing any medications needed during their pet's stay. Please ensure your pet has enough of his/her required medication for their time boarded or for his/her day in day care.

**Belongings:** We want your pet to be comfortable during his/her stay. We request you to bring your pet, special food, and any medications. We will provide bedding, bowls, and food, if you choose not to bring your pet's own food. You are more than welcome to bring anything extra to make your pet feel more at home. Keep in mind we cannot guarantee these items will remain in the same condition. **INITIAL:** \_\_\_\_\_

**Illness while boarding:** Please be informed that it is not uncommon for pets to not eat or to have diarrhea while boarding. We keep a clean, calm, routine-based kennel, but pets can become stressed or overexcited easily in unfamiliar settings. We will inform you of any issues your pet may have during boarding, and we will treat them (if necessary) upon your approval.

**Emergencies:** If an emergency should arise while your pet is being boarded, we will contact you immediately. If you would like to leave another emergency contact, do so upon check-in. In the event we are unable to contact you or the emergency contact provided, necessary healthcare will be provided at a cost of the owner. **INITIAL:** \_\_\_\_\_

**Abandoned Pet:** If pets are not picked up by agreed time, you may be subject to additional fees. If any pet is abandoned in our care, we will continue to care for the pet for 48 hrs. If there has been no contact or attempt to pick

up your pet, Three Happy Tails will turn over said pet to animal control. Any expenses occurred during the 48 hour hold or from animal control will be paid for in full by owner of pet.
